For 23 months strong, Animal Humane has maintained a 100% adoption rate for every healthy pet in our care. Since 2006, we have spayed and neutered over 42,000 pets at our campus donor-subsidized veterinary clinic. This tremendous achievement has led to an 11% decrease in intakes community wide from 2006-2010. A Dog Agility Park capital campaign was successfully completed, raising \$118,000 and the project was completed in 2010. Animal Humane received our first Maddie's Fund Coalition grant, and Spay New Mexico was launched. Two additional Adoption and Training Centers were opened in the first half of 2010- 9132 Montgomery Blvd NE and on the Westside at 10700 Corrales Road. Our active volunteers have increased by 24% over the prior year. Employee turnover has decreased by almost 20% and
