## annual report fy 2013/2014



### our committment to saving lives

Our 48th year will be remembered for our incredible Main Campus transformation. Thanks to Project Humane, 615 Virginia Street is now a healthier, more beautiful and functional facility for our pets, staff, volunteers and the public. After moving into Big Blue, our new Adoption Center, in June 2013 we proceeded to build or renovate three more buildings: Tiny Teal, our new Admission Center, was completed in October 2013; the complete makeover of our Kennels was finished in March 2014; and the renovation of the former Adoption/Intake Building into a stunning multipurpose cat facility, the Robbie Jones Memorial La Casa de Los Gatos, was completed in June. Phases VI & VII, landscaping and our Clinic Annex, will be completed in Fiscal Year 2014/2015.

Our new facilities have hit the mark. Pets in our care are staying healthier and happier. The public loves our welcoming new facilities. Our staff and volunteers are able to be more efficient in their day to day tasks. And all of our hard work has resulted in a 92% Live Release Rate. Indeed, we have saved more lives. We are so grateful for the incredibly generous support from our donors, who made our transformation possible.

Other milestones in Fiscal Year 2013/2014 included the reintroduction of a summer day camp for kids, Camp Humane and the award of a major grant from the ASPCA's Community Partner Program. Camp Humane was a huge success, with 44 campers enjoying the excellent curriculum created by our skilled Education & Outreach Team. We enjoyed overhearing campers talking about the importance of good ventilation to keep pets healthy, and how vital spay/neuter is for reducing pet overpopulation. Mission accomplished!

Albuquerque was one of two cities selected to participate in ASPCA's Community Partner Program (CPP). Animal Humane and the City's Animal Welfare Department are now collaborating on several initiatives to increase our community's adoption rate, increase spay/neuter, and reduce intakes into our shelters. Together, we are implementing programs that focus on Pit Bull and Chihuahua-type dogs because they make up the majority of our shelter's populations.

We are geared up and ready to move into our next half-century and have saved tens of thousands of lives already, thanks to the dedicated work of our Team, Volunteers, Board and precious donors.

In 2012, Animal Humane launched **Project Humane**, a \$5.6 million capital campaign intended to transform our Virginia Street campus into a beautiful, welcoming place for pets and people alike. Our goal was to upgrade our facilities and campus using a Master Plan developed by one of the country's leading animal shelter architecture firms, Animal Arts. The plan called for a combination of humanely designed new construction and renovation of existing buildings. Our resident housing would be upgraded to offer compassionate shelter that promotes and restores health for the pets we serve, and our 4-acre campus would become a center for meeting, adopting, training and learning about pets. We are delighted to revisit our original key outcomes, and demonstrate the progress we've made with your passionate support.

Animal Humane is a private 501(c)(3) nonprofit organization that receives no city, state or federal funding. Rather, we are responsible for earning or raising 100% of our \$5.4 million dollar annual operating budget. We are fortunate to produce revenue from three streams that generate 30.8% of our annual budget: 1. Fees from Adoption and Training classes; 2. Fees from services performed in our Donor-subsidized Veterinary Clinic for low-income pet owners; and 3. Revenue from our Thrift Shop, our three Animal Outfitter Pet Supply stores, and sales of donated motor vehicles.

The remaining portion of our annual budget is raised through private donations from individuals as well as contributions made from businesses, foundations and donors including Animal Humane in their estates. Private donations have made it possible for Animal Humane to successfully meet the needs of homeless pets and pet owners for the past 49 years. Every contribution is valued and judiciously used to operate the 20 programs that comprise our comprehensive Circle of Care.


## Adoption & Intake Statistics

Since January 2010, Animal Humane New Mexico has successfully re-homed 100% of the healthy pets in our care! In Fiscal Year 2013/2014 our Live Release Rate, or Save Rate, reached an all-time high of 92%, and continues to grow. This is possible due to our comprehensive Circle of Care that provided more veterinary care, offered more behavioral assistance, and served more pet owners with services to keep pets in loving homes. Lives are being saved, and your support makes our work possible.



## nurturing future generations

Respect, responsibility, kindness, compassion and citizenship: these are the qualities we want our children to acquire to ensure a positive community to come. This summer saw the launch of Camp Humane, a 5-day educational summer camp for students ages 8-13. Over the four weeks of camp, 44 students from schools across Albuquerque and the surrounding



### In Fiscal Year 2013/2014:

- Reached 5,165 students with lessons on pet care and building empathetic and respectful relationships with others, a 70% growth over the previous year.
- Of those, 69% were school children under the age of 10, and 20% were youth in middle or high school.
- We reached all these people through 8,655 contact hours, 37% of which were repeat contact hours—where a student received a 2<sup>nd</sup> lesson.
- We presented to a total of 49 Albuquerque Public Schools and 13 private schools, impacting 31% of the APS school district.

area participated. Not only did they play fun games and make crafts; they also learned how shelters work, about careers with animals and what thought should go into adopting a pet. They learned how to care for different types of pets, from turtles and tortoises to hedgehogs and horses, as well as for unowned pets like community cats.

Our skilled Team was supported by five high school aged Junior Volunteer Counselors, who helped wrangle campers and learned just as muchif not more-about responsibility and reliability. Through four week-long sessions of Camp Humane we were able to provide a total of 1,659 contact hours of valuable lessons of Humane Education. These combined lessons, in the minds of our young campers, are working to strengthen our community and build a more humane society for generations to come. By planting these lessons of compassion, respect and responsibility at a young age, these young activists will grow and bloom into passionate life-long animal advocates. In the end, homeless pets are the real winners.

## saving lives statewide

Our Team was preparing to drive down to Roswell to pick up several dogs from their municipal shelter when we saw a powerful photo on Facebook of a sweet looking dog cowering with her head down. It was the saddest photo of a young stray dog, completely shut down and helpless. Our Director of Adoptions sprung to action and worked with a local rescue group to pull her from the shelter one day prior to her scheduled euthanasia. Our Team arrived the next day to drive sweet Melody and 28 dogs 197 miles into our loving care.

Stories about overcrowded shelters happen all too often, but Animal Humane is here for those pets when they need us most through our statewide pet transfer program **Project Fetch**. One by one, we transform the lives of pets that are homeless, emotionally shut down, sick or injured and give them access to resources they would otherwise not receive.

Melody was so terrified of people that she wouldn't eat, drink or walk. Our passionate Behavior Team spent an entire month working with her. At times we had to hand feed her, just to make sure she would eat. Through a great amount of training, daily playgroups and positive association, we were successful in pulling this sweet girl out of her fearful shell. Some pets may take a little longer to heal and require more resources to transition from homeless to loved, but every pet we save is worth the effort. Melody began her new life with a new family in March 2014.

#### In Fiscal Year 2013/2014

- We transferred 1,372 at-risk pets into our care, a 25% increase over the previous year
  - 997 canines
  - 375 felines
  - This includes 446 transferred from Albuquerque's Animal Welfare Division
- We helped 20 shelters, agencies and rescue groups statewide
- We provided support to shelters in 13 different counties in New Mexico that comprise 62% of our state's population, in some of the most rural areas



## our medical team at work

Animal Humane's **Donor-subsidized Veterinary Clinic**, located on our Virginia Street Main Campus, plays a crucial role in ensuring pets stay healthy. Our talented team of 3 full-time Veterinarians and 16 Veterinary Technicians and Assistants treated THOUSANDS of shelter pets, as well as owned pets. We sterilized 4,366 cats and dogs in Fiscal Year 2013/2014, making a huge impact on pet overpopulation in our community. In addition, we served thousands of owned pets at our **Monthly Vaccination Clinics** and through the comprehensive care offered daily to qualifying low-income families.

### esme's journey

Esme is an amazing story of success and team work. She arrived at Animal Humane New Mexico as an infant kitten. She immediately entered our Foster Care Program, but crashed overnight. When she arrived in our Donorsubsidized Veterinary Clinic early the next morning she was hypothermic and barely conscious. Our skilled medical team immediately began working on getting her warm and supplementing with oral glucose to keep her blood sugar up. Once we warmed her body, we fed her through a tube because she would not eat on her own. Within the hour, she went from a ball of fur barely able to raise her head to a meowing, sassy kitten demanding food. She was so ravenous that she buried her toes and face in the food... making quite a mess! We sent Esme home with one of our dedicated Veterinary Technicians to watch over her as she continued to recover. She made it through that night, the following night and the next week. As the days passed, our passionate Veterinary Team continued to nurture, monitor and administer care to save Esme's life. After 62 days in our care, Esme was healthy enough to be available for adoption.

This was possible because of the quick response and talent of our Foster Care and Veterinary Teams. At this moment, Esme is in a loving home, sassy and bossy like any calico should be.

Our **Pet Save Fund** offers extra veterinary care to pets to relieve their suffering, enable them to return to their homes, or be ready for a new one. In FY 2013/2014 we provided 986 cats and dogs with \$138,755 in subsidized care through 1,309 procedures.

Every day, our skilled Veterinary Team is doing more than just helping the homeless pets in our shelter; they're also providing critical services to families who wouldn't otherwise be able to afford veterinary care for their beloved pets. When Audrey's Shih-Tzu Bronson developed a tumor in his armpit, she feared she would have to euthanize her sweet dog, until a friend told her about the comprehensive services offered in our Donor-subsidized Veterinary Clinic. We helped Bronson through a leg amputation, a ruptured ulcer in his eye and a host of ongoing

preventive care. We provided Audrey with peace of mind, while treating Bronson with compassion and high quality care. After years of thoughtful care and dedication to this sweet dog, Bronson passed over the rainbow bridge in June 2014. Nevertheless, Audrey says that she will continue to bring her pets to our Clinic because our staff is supportive of both pets and pet owners.

## teaching new tricks

Animal Humane's **Behavior Department** plays a pivotal role in the mission of Animal Humane by helping pets remain in their homes and increasing the adoptability of the homeless pets in our care. Our talented Behavior Team offers private and group behavior training classes to pet owners (and their dogs and cats). They also provide valuable Behavior Modification Training to our pet residents in the form of enrichment and socialization activities as well as basic manners instruction.

New York came to us in August 2013 as a stray kitten. She was fearful and undersocialized to human handling—she naturally perceived us as a threat. After



her spay surgery and a brief recovery in a Foster Care home, New York returned to Animal Humane and was placed into our Behavior Modification program. During her two week stay, she was provided with guided activities and resources to help her learn that people are friendly, not harmful. By the time she graduated from our program, she no longer exhibited aggression and pursued cuddles and affection from our talented Behavior Team. New York was adopted in September 2013 and is thriving in her new home, with support and counseling from our Behavior Team.

- Provided 87 classes and workshops to a total of 422 pet parents
- Served 1,050 pet owners with thoughtful assistance through our FREE Behavior Helpline (505.938.7900)
- Saved 50 shelter pets with comprehensive Behavior Modification plans

# community partnerships & programs

Animal Humane New Mexico is committed to the health and happiness of homeless pets and passionate pet owners statewide. To this end, we've established a host of programs and partnerships to serve the evolving needs of homeless pets, owned pets, rescue groups, shelters and other animal welfare professionals throughout New Mexico.

Free Behavior Helpline—connects pet owners with our skilled Behavior Team.

Monthly Vaccination Clinics—grants the public access to affordable vaccinations and microchips for their cats and dogs.

**New Mexico Humane Conference**—provides two days of educational opportunities annually to animal welfare professionals, rescue groups and volunteers from New Mexico and surrounding states.

Pet Food Bank—serves families who are facing financial hardship.

Pets for Seniors—subsidizes the cost of adoptions for humans 65 or older.

**Project Fetch**—transfers pets from shelters and rescue groups statewide into our care.

**Trap-Neuter-Return (TNR)**—reduces the numbers of kittens and cats flowing into shelters and improves quality of life for community cats in managed colonies.

Warm Hearts Network—provides supervised pet companionship from shelter pets trained as therapy dogs to persons in hospitals, recovery centers and nursing homes.

ASPCA Community Partnership—established a multi-year collaboration between Albuquerque's animal shelters to increase our city-wide Live Release Rate.

**Paws & Stripes**—utilizes our Main Virginia Street Campus to train service dogs for military veterans with post-traumatic stress disorder and traumatic brain injuries, and adopts our dogs into their program to serve their clients.

### driving sales to save lives

In March 2012 we relocated our popular Thrift Shop to 4646 Menaul Blvd. NE. This was the first part of Project Humane and a huge change for our staff, donors, volunteers and faithful shoppers. However, from the moment we opened the doors at our new location, foot traffic from both shoppers and individuals donating items for resale surpassed levels at our previous Virginia Street site. Our 6,000 square-foot Thrift Shop is full of bargains-and generates revenue that is vital to our passionate life-saving work. From dishes and vinyl records to electronics, pet supplies and automobiles...every donation and every purchase benefits the at-risk pets we serve.

In Fiscal Year 2013/2014, our Thrift Shop's Gross Revenue increased 17% over the previous year to \$647,592. Our net income was \$331,693, 51% of revenues generated. Revenue from our Thrift Shop represents 13% of our annual operating plan and is a critical source of funding for our services and programs.


