TAKING TIME TO HEAL:

Belinda's story

Waiting in a small kennel at a rural shelter for a forever family took a toll on Belinda. Despite the shelter's best efforts, she had quietly retreated further and further into her shell. **This shyness, accompanied by discomfort at being touched, made it difficult to connect with her.**

But these minor setbacks didn't stop us from trying! When our Adoptions Team visited the other shelter as part of our Project Fetch statewide pet transfer program, Project Fetch, they were certain we could help the 4-year-old Plott Hound find her confidence again!

So they loaded her up (along with 25 other pets from the same shelter) and brought her to our campus — where your love and support made it possible for Belinda to plot a new course.

Our team quickly discovered that, in spite of her discomfort, Belinda possessed an incredibly sweet and playful personality.

We also quickly learned that some of Belinda's handling sensitivities came from physical discomfort when our Donor-subsidized Veterinary Clinic Team removed a foxtail that had burrowed into her ear. Our Behavior Team quickly followed up with a behavior training plan created specifically to address

Belinda's other sensitivities. She aced it and "graduated" from her program in two weeks.

Meanwhile, our volunteers were providing Belinda with the love and attention she craved and that she was starting to accept more freely.

Her time in veterinary care and receiving behavior support had already ensured that Belinda was here far longer than the average pet. **But, like you, we know that the quality of care your valuable support allows us to provide is more important than the speed with which pets move through our shelter.** Together, we are here for homeless pets like Belinda for as long as it takes for their happy ever after to arrive.

And Belinda's finally did! After 83 days in our care, Belinda's quest for a loving home was finally achieved. There would be no more kennels or lonely nights in her future. Instead, Belinda's future holds comfort, security, love and plenty of room to run on her family's fenced acreage.

Belinda's story wouldn't have been possible without the amazing support of donors like you. Thank you for making magical connections between happy pets and people possible.

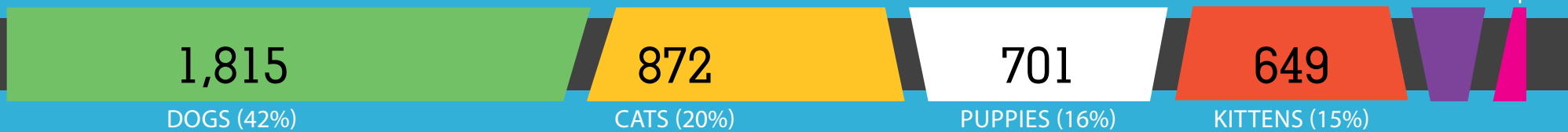

Girly's story

At just 4 weeks old, Girly arrived at our Clinic as a rescue in desperate need of medical care for several serious health problems. In addition to an upper respiratory infection and several intestinal parasites, the tiny kitten had several holes in her ears from what appeared to be cigarette burns. Her whiskers and eyebrows also looked singed, and she weighed less than a pound.

Kelly, who has worked at Animal Humane for 11 years, became one of two foster caregivers Girly would have over the next several months. Kelly admits, "I quickly decided that if her other foster mom didn't adopt her, I would."

Slowly but steadily, because of the care your wonderful support provides, Girly's ailments healed. Finally, only a single health issue remained. Though she had received treatment, the digestive parasites were causing her to have trouble using a litter box and controlling her bowels. Kelly explains, "This is the kind of issue many adopters are not willing or able to handle." Undaunted, Kelly took Girly into her life full time, patiently helping her through this final hurdle.

Watching Girly explore and play at her mom's desk, it is obvious that the feisty kitten's painful ordeal is in the past. Kelly proudly says, "You'd never know that anyone ever hurt her. She loves attention and is very affectionate. **Every day she is a reminder to me not to hold a grudge.**"

Girly is a great example of how your donations make it possible for our Donor-subsidized Veterinary Clinic to save lives. **We thank our Friends of the Clinic supporters who share our belief that every homeless cat and dog deserves the best care possible.**

From dog walkers to Thrift Shop sorters, volunteers make Animal Humane hum with a vibrant energy that stems from a shared love of pets. But for one group of very special volunteers, their time at Animal Humane offers a chance to slow down and to practice both calmness and reading skills. These special volunteers, our Page Pals team, are pet lovers between the ages of 6 & 15. Markus Huerta, 13, has been a part of the program since its inception in 2015.

Coming from a family of dog lovers, Markus found out about the Page Pals program from his grandmother, Animal Humane volunteer dog walker Lynn Gates. **Through the program, Markus shares that he has learned “a lot about how to work with cats and kittens, and a lot about how funny they are.”**

But more than simply fostering a love of cats and encouraging a love of reading, Page Pals provides young pet enthusiasts with a tool that can help them achieve future goals! Wanting

to be an actor, Markus explains, "I would skip big words sometimes when I was reading silently. But when I'm reading out loud to the cats, I can't do that. It's made me a better reader and speaker." His grandmother, who usually accompanies him, agrees: "He's gained a lot of confidence in his reading and in himself."



Markus' new appreciation for the joyful nature of cats has

been contagious. Recently, Markus and his family adopted a new feline friend — the kitten Marty Stuart — whom Markus fell in love with during one of his Page Pals reading sessions! In addition to introducing cats and kittens to potential families, our young readers help socialize our feline residents, reducing their stress and increasing their adoptability.

It's clear to Markus and to the team here at Animal Humane that when kids, cats and tall tales come together, the odds are always in their favor!

FINDING FAMILY:

an unconventional foster care tale

Purrsephanie, a stray cat, arrived at Animal Humane as kitten season was starting. She was pregnant, and we knew it wouldn't be long before this sweet, gray Tabby had a litter to care for. Sure enough, the next day, Purrsephanie gave birth to four kittens right in our Foster Care office.

A wonderful mother, Purrsephanie doted on her kittens for several weeks, both in our Foster Care office and in a foster care home. Then, just before Mother's Day, the kittens were ready to be weaned.

The wonderful support of our donors gives us the opportunity to find creative solutions that truly help pets in need. For Purrsephanie, the end of the journey with her own kittens was just the beginning of her journey as a mom!

Just as her babies were weaned, a couple arrived at our shelter with four tiny kittens of their own. Kittens so small their eyes were still closed and their umbilical cords were still wet. Samantha Montgomery, Foster Care Manager, knew they needed to move quickly to save these precious lives.

They called Purrsephanie's foster parent who immediately brought this adorable cat and her newly-independent kittens back to our Main Campus.

Our Foster Care Team carefully introduced Purrsephanie to the mewling babies and waited, breathless, as she examined the hungry kittens

before her. We needn't have worried!

Purrsephanie's heart must be as big as yours because she took to these vulnerable new babies without hesitation — grooming and nursing them almost immediately. The quintet stayed in the Foster Care office overnight, with our team checking in on them frequently. By the time the sun rose, Purrsephanie and the kittens were a cuddly feline family.

Purrsephanie fed and cared for these fragile youngsters for 10 days, providing them with vital nutrients and teaching them how to be cats. When her milk dried up and the kittens still needed to grow before they were ready to go home with new, loving families, another experienced foster, Ashley Jinzo, stepped in. The kittens spent 54 more days learning and growing alongside other kittens in Ashley's dedicated foster kitten room.

Just like Purrsephanie and Ashley, you consistently come through for pets in need.

From sick or hurting, to happy and healthy, the pets at Animal Humane know love and compassion because of you.

Today, because of your generosity and the dedication of our team and volunteers, Purrsephanie and all her kittens have become beloved members of families. **These nine lives stand as a testament to the lasting impact you have made, and that you continue to make, on pets in need.**

Fiscal Year 2018 saw Animal Humane's newest development, The Center at Animal Humane, continue to grow like a hungry puppy! With Phase I (Agility Fields and our Pavilion and Training and Behavior classrooms) complete, 581 eager students and their dogs learned, played and bonded in agility and behavior classes.

According to Trevor Driggs, The Center's Operations Director and a 10-year Animal Humane team member, **"The Center is a tool to help keep pets in homes. Our positive reinforcement-based classes are designed to help people build stronger bonds with their pet and learn how to encourage positive behavior changes."**

COMING SOON!

Renovation and construction of The Center's second and largest building, Doggie Day Care & Boarding, began October 2017. Our talented Facilities Team is overseeing the construction and we anticipate that Phase II will open in the new year!

In addition to offering great day and overnight care for dogs, our Doggie Day Care & Boarding will provide much-needed

earned revenue to support our mission — saving & sheltering thousands of homeless pets each year and finding them wonderful families.

Construction on Phase III will begin in early 2019. Our final renovations will include a building directly facing Wyoming Blvd., where we will offer puppy pre-school and human-only instruction. Both are vital components of our ultimate goal — keeping pets happy and in loving homes. Other features of Phase III include a white room for our Volunteer Photography Team and a Shelter Pet Showcase, where passersby will have the joy of watching adoptable dogs as they enjoy enrichment, exercise & training.

Generous donors to The Center's Capital Campaign have already made exciting transformations possible on our newest 2.28 acres, but several attractive recognition opportunities remain.

Animal Humane New Mexico is a private 501(c)(3) nonprofit organization that receives no city, state or federal funding. We must earn or raise 100% of our annual operating budget.

In Fiscal Year 2018, earned revenue was generated through the following: 1) Fees from Adoptions 2) Fees from services performed by our Donor-subsidized Veterinary Clinic 3) Fees paid to attend Train Humane & Agility Classes at The Center at Animal Humane 4) Revenue earned at our Thrift Shop, Main Campus Animal Outfitters and Westside Adoption Center Mercantile. The remainder of our operating budget was raised through private contributions from dedicated pet lovers, generous sponsorships and grants from corporations and foundations, and legacies of love in the form of estate gifts. Each donation makes a life-changing difference to the pets in our care.

Animal Humane is honored to hold both Charity Navigator's coveted 4-star rating and Guidestar's Platinum Participant rating. These ratings independently signify our continued commitment to accountability, transparency and the judicious use of every dollar earned or donated.
