

Kettle Claws helps child with depression





ast spring, my 6-year-old son curled into a ball on the floor of his bedroom, sobbing and said that he didn't want to be on earth anymore. He said he hated himself and believed the whole family would be happier if he didn't exist. I've never before felt pain and fear like I did that night.

We took him to a psychiatrist who diagnosed him with depression. He was dealing with two losses, coupled with a genetic predisposition to depression that ultimately led to a breakdown.

He has been seeing a therapist ever since that scary night, and he's doing better. But, the major turning point was when my son met a kitten he named Kettle Claws.

The kitten's personality matches my son's exactly (when he is not in a depressed state): exuberant, playful, adventurous, active and curious. Kettle Claws has helped bring those traits back out in my son. His laughter when the kitten pounces on a toy car or chases him and a string down the hallway makes




me want to weep, because I genuinely didn't know if our boy would be able to come out of the despair he felt. Things are getting

better, in no small part due to the kitten our family adopted.

Depression in kids is a real thing, but **so is complete devotion to and love for a pet.** I will be forever grateful for Kettle Claws.

Duggie gives hope to little girl



What we didn't know was **the incredible lengths Duggie was willing to go in order to comfort & protect his new family.**

When he was adopted by Sally & her children, Duggie became fast friends with the 14-year-old daughter Kali, who has epilepsy. Duggie started sleeping at the foot of her bed & accompanying Kali on errands. The pup stays by her side, particularly on days when she wasn't feeling her best.

One night, while Kali was cooking dinner,

she began having a seizure. Kali fell to the ground, and Duggie quickly jumped into action without having any prior training.

"Duggie managed to drag her by the shirt collar into the dining room, and he even propped her head up by laying his neck under her until she recovered," explained Sally, Kali's mother. **"It was an amazing and loving act to witness."**

Since the first astonishing act of bravery, Duggie has sensed two additional seizures and has provided endless love & support as Kali recovered from each.

The family says life has been more positive since adopting the Animal Humane alum. They may have rescued Duggie, but **they believe Duggie is the one who has truly rescued them.**

Jodi inspires a healthy & joyful lifestyle

L ouise & Joe had never had a pet. Following a life filled with world travel and adventure, Joe was diagnosed with Parkinson's disease. As a result life became more sedentary for the couple.

"We thought a beloved pet would fill our home with life & energy," says Louise.

Little did they know, their new fur-baby would do so much more. Though they had every intention of adopting a dog, it was a 4-month-old kitten who stole their hearts.

Named Jodi, after Joe, the orange Tabby had come to Animal Humane with a sibling as part of a stray litter. Happy & healthy, the young feline was quickly cleared for adoption, and two days after arrival, became a permanent part of Louise & Joe's family.

When Joe was undergoing physical therapy & he was prescribed a daily walk and, like many of us, he needed a little motivation.

"We purchased a cat stroller which could serve as a 'walker in disguise' for Joe," says Louise. "Ever since, Joe gets his exercise and Jodi gets to see the world."

Jodi became his inspiration and brought joy back into their home. And like Jodi, their daily walks became a joy, too.

safety net is saving lives

S tephanie and her husband had both been furloughed from their jobs when their dachshund, Mimi, fell ill in March.

The 11-year-old pup wasn't acting like her playful, energetic self. She was lethargic, wouldn't wag her tail and was biting at her water instead of lapping it up.

"We knew she wasn't feeling well," explained Stephanie. "Our kids were devastated to see her like that."


Though finances were tight, **their beloved Mimi needed help**, so they took her to the vet. After maxing out their Care Credit card and spending all they could to run tests, they received the unfortunate news. Mimi had a 2-inch mass under her tongue and needed a costly surgery. Stephanie was distraught. There was no way the family could afford additional medical care. With no other choice, she contacted Animal Humane to surrender her family's beloved companion.

Because of you, heartbreak wasn't the only option. Instead of a surrender appointment, our Admissions Team referred Mimi to our intake intervention program — Safety Net. This program helps keep pets out of the shelter by subsidizing the cost of care at emergency veterinary clinics when Animal Humane's Donor-subsidized Veterinary Clinic is unable to help.

"It was such a relief," says Stephanie, "I couldn't help but cry." Your generosity helped cover Mimi's surgery. As a result, **you not only** saved Mimi's life, you kept a sweet family together.

"When Mimi came back from surgery we shared with our kids how much Animal Humane had helped her," says Stephanie. "They were over the moon. It was life changing for my kids. We are so thankful."

Every day through your support of our Safety Net program **you are preventing unnecessary pet surrenders, saving the lives of pets like Mimi and giving their families hope.** Thank you!

full bellies & happy homes

Our dogs & cats are with us through all of life's ups and downs. They provide us with constant companionship and endless joy. Sometimes, whether we're facing a job loss, medical emergency or other unforeseen financial situation, we need a little extra help caring for them.

When pet owners fall on hard times, **you** ensure their treasured dogs & cats continue to receive healthy, yummy food through our Pet Food Bank. For a \$1 donation pet owners, like Lobo's humans, can receive food to feed their four-legged family members each week.

The pet food we distribute comes from partners and businesses around Albuquerque, and from personal donations from pet lovers like you. Our Pet Food Bank is also nearly 100% staffed by caring volunteers. "You are helping me afford to feed my pets." - Brooke, Pet Food Bank recipient

A bag of pet food may not

seem like much, **but this small act of kindness makes a big difference for families in our community.** It keeps their pets happy, healthy & thriving and keeps loving families together by preventing owner surrenders.

When researching the link between human and animal food insecurity a study from the University of Pittsburgh revealed that having a pet is associated with better food security than when people did not own a pet. Additionally, because our pets provide emotional and social support, in turn owners may be more motivated to visit a food pantry and manage the household finances so that they can continue to care for their pets.



SAFETY NET & PET FOOD BANK COVID-19 RESPONSE

Though COVID-19 put many of our programs on hold, because of you, essential services provided by our Safety Net program and Pet Food Bank never wavered.

Our Safety Net program continued offering intake intervention services for cat & dog owners

actively looking to surrender their beloved pets due to medical, behavioral or temporary housing needs. This spring & summer you made it possible for 31 pets, including Mimi, to remain with their families in their loving homes.

Our Pet Food Bank continued to distributed cat &

dog food twice a week on Sundays & Thursdays to families struggling to feed their pets. Your generosity throughout the pandemic provided pet food for 2,118 individuals.

even in the darkest of times there is HOPE



S he arrived with sad brown eyes. Her pain came from the infected wounds and deep lacerations covering her 40-pound body. The 3-year-old Shepherd cross was also heartsick after being abandoned in rural New Mexico.

Her wounds revealed that she had lived alone for days days without medication to ease her pain, days without a comfortable bed on which she could rest and heal, days without the loving touch or soothing voice of a caring human.

Then you came into her life. You would heal her body inside and out. You would give her a second chance to find love again. Because of you, we named her Hope.

Hope came to us in May, when our shelter was operating at limited capacity due to COVID-19. Very few Team members were on our Main Campus and we were only accepting emergency intakes. Hope definitely qualified. But, without your incredible support during these tough times it would have been impossible to provide her with the care she desperately needed.

Because you believe pets deserve the very best, even during a pandemic, Hope received the necessary medical care — and so much more!

Hope was immediately seen by one of our veterinarians, Dr. Kim Hamel, who prescribed pain medication and antibiotics. Her injuries were flushed to clean them and dressed with ointment. One short day later, Hope went into surgery. The severe lacerations that traversed her back, elbow and hind leg were again cleaned and then stapled closed.

For 14 days Hope was monitored closely as she rested and remained on medications. In mid-June the sweet girl's infection

had disappeared and her staples were removed. Hope was walking again and eager for the future.

Hope was adopted two months after you came to her rescue. Today she is enjoying her new life, pain free & comfortable, surrounded by her amazing humans.

Hope's journey shows the lengths

you are willing to go, even during a pandemic, to rescue New Mexico's pets in need. We will be forever grateful for the lives you have changed and for your resilience during very challenging times.

CLINIC COVID-19 RESPONSE

Many of our normal Clinic operations were deemed non-essential during COVID-19. Beginning on March 23, our services were restricted to urgent & emergency care for pets with an active Veterinarian-Client-Patient-Relationship and necessary care for all pets in our shelter's care. With your support, we continued to meet the needs of every pet we could while exploring innovative solutions to help us expand our service reach.

Our Team made additional adjustments to allow for safe, no-contact interactions including curbside pick-up & mailing of prescription medications. We also implemented telemedicine appointments with our veterinarians providing 46 consultations over the telephone.

Spay & neuter surgeries resumed on May 6, as did in-person appointments of essential & nonessential services for current & new clients, though they now featured curbside check-in and other social distancing accommodations. Trap/ Neuter/Return services remained limited throughout the end of the fiscal year.

Since its inception in 2009, our CAT program has resulted in **2,038 total feline adoptions.**

2,000 cats and counting


Arsellus Wallace was dressed and ready for a night on the town from the moment he arrived at Animal Humane. And, with your help, we were ready to take him on a new adventure.

The adorable tuxedo cat came in as a stray. Though he was found alone, the 3-year-old was no stranger to humans. In fact, he was quite the charmer.

Cats like Marsellus Wallace — with charismatic personalities and adventurous spirits — are often recruited for our Cats Around Town,

or CAT, program. Through this special program cats & kittens are showcased in Albuquerque businesses, who value pets like you do. This additional exposure often leads to quicker adoptions. The average length of stay for cats at our shelter is 16 days. However, when placed at a CAT partner location, the average length of stay is only 7 days.

This was certainly true for Marsellus Wallace. He was placed with our partners at Gamers' Anonymous on a Wednesday and adopted in less than 48 hours! And,



while we celebrate each family that is made whole by a new pet, Marsellus Wallace gave us another reason to celebrate. **HE was our 2,000th cat adopted through this life-saving program.**

When cats are housed off campus through our CAT program, space is made available at our shelter to take in even more homeless & at-risk cats who need your help. **Through this program you are** serving not only the felines chosen to participate, but our entire cat population.

Camp Humane goes virtual

A nimal Humane's camps have inspired young animal advocates since 1997. Typically, during the summer months our campus is flooded with curious students whose passion for pets always inspires our Team and Volunteers. This year these future animal welfare advocates, veterinarians and pet lovers flooded our computer screens instead, as Camp Humane went virtual.

Knowing the importance of Humane Education, our innovative Education & Volunteer Teams curated a new Camp Humane website filled with learning materials, craft tutorials, campus tours and more to provide campers with an incredible online camp experience. From 9 am – 12 pm during the five day sessions, students could join in live Zoom video sessions hosted by our Humane Educator, Jeanne Frye-Mason.

"Though our students were not here on campus with us, their excitement and engagement was awesome to see," says Ellen Schmidt, Senior Director of Adoptions, Outreach & The Center.

Similar to our in-person camps, virtual camp sessions let children explore animal-related topics, learn more about pet care and discover how humans can help animals and the environment. Campers and their parents reported this year's camp was both educational and entertaining.

"I am quite amazed at how you kept my kid engaged for three hours every day, and always with glowing reviews at the end of the session," said Lisa B, whose child Ruby attended camp.



Like our Main Campus & Westside adoptions, our CAT program was also suspended briefly during the height of the pandemic. As soon as our CAT hosts reopened for business our program resumed. Despite being temporarily on hold, last fiscal year 8% of Animal Humane's cat adoptions were facilitated through Cats Around Town and 215 fabulous felines found forever homes.

Our Thrift Store was the first Animal Humane service affected by COVID-19. In mid-March the store closed to the public and remained closed through June 8. Over those twelve weeks, we estimated a loss of \$60,000 per month for a total of \$180,000. When Thrift did reopen our policies were updated in accordance with state orders. Through the remainder of the fiscal year the number of shoppers inside our store was reduced. With losses from the Thrift Shop, your generous donations were crucial in continuing our life-saving work.

foster care

Because of you **918 dogs, cats, puppies & kittens** were cared for by loving Foster Caregivers this fiscal year.





Vader finds his **second chance** amidst the pandemic

A playful Australian Cattle Dog named Vader was surrendered to the Bernalillo County shelter early this year. **You gave him a second chance at finding the perfect home** when he was transferred into our care in January through Project Fetch.

What we thought would be a simple and quick journey for Vader turned into a considerably longer stay at Animal Humane when he tested positive for heartworm. In spite of this setback, you remained in Vader's corner, fighting for him every step of the way. Vader was placed with a temporary Foster Caregiver and he began intensive heartworm treatment.

For three months Vader received medications and regular health checks. And, he continued to receive this life-saving treatment even as we adjusted during a global pandemic. Finally, Vader was cleared for adoption. But COVID-19 prevented him from returning to our Main Campus to find his forever family.

Like many other dogs, the 4-year-old was placed back into Foster Care as part of our Fetch Some Fun program. And like 86 other pets placed into temporary Foster Care, Vader's Foster Family fell madly in love with him. He was adopted in late April – a true foster win!

You have shown time and time again that for pets like Vader, nothing can stop your love. Thank you for being there when New Mexico's dogs & cats needed you most.

eisha's best friend passed away in early 2020. The beautiful Torbie cat had spent the last nine years with her loval human companion. Then one day, her family was gone.

Understandably, Meisha was agitated and wanted to be left alone when she arrived at Animal Humane. Originally adopted from us in 2011, the 15-year-old hadn't been back to our Main Campus since then. Meisha was confused and missing her home, but you provided her with a safe space to decompress. She was met with patience and kindness as we waited for her heart to heal.

After a few days to cool down, Meisha was declared healthy by our Clinic Team and made available for adoption. But, the shy airl had a difficult time attractina the attention of potential adopters.

Meisha waited patiently for six weeks, and suddenly the COVID-19 pandemic struck. As your donations and love poured in, Meisha went to live with a Foster Careaiver as part of our brand new Purr-cation program — a COVID-19 created program to reduce stress and increase positive interactions for our felines during the shutdown.

It was in her Foster Home that Meisha began to thrive. Because of you, she found comfort and confidence once again in the warm home environment. She slowly opened her heart to the possibility of a new family.

Meisha was only in her temporary home for three weeks before her Foster Mom started to suspect that she wouldn't be leaving. They'd grown very fond of the gorgeous girl. And, both Meisha and her Foster Family knew they made the perfect match. Thank you for giving Meisha a second chance at love and making her heart whole again.

FOSTER CARE COVID-19 RESPONSE

On March 23, in accordance with Gov. Michelle Lujan Grisham's "stay-at-home" public health statewide Animal Humane continued directive, emptying our shelter in effort to keep pets,

and at the lowest risk of exposure. With your support we placed our dogs & cats into temporary Foster Care homes through our new Fetch Some Fun & Purr-cation programs. We also put out a call for additional shorttheir people, our staff and volunteers safe term emergency Foster Caregivers to help

meet this need. You answered that call and as a result 141 pets were kept safe & secure. Eighty-seven of these dogs & cats met their forever families and were adopted through their temporary placements.




